Opening:

The President along with the rest of the members of the board expressed their gratitude and appreciation that Gerry Bing was able to attend the meeting today.

Handicap Director Report:

1. The Handicap Director updated the Board with the latest CVMC membership. 84 total members; 78 full memberships, 4 associates, and 2 comped members.

Treasury Report:

1. The Treasurer reported there was \$2,608.70 in the CVMC account. \$1,162.00 for rounds paid and \$700.00 for member dues have yet to be deposited. Expected expenditures are: \$500.00 for added money events, \$1,300.00 (est.) for the year-end banquet, and \$600.00 for trophies, plaques, and awards.

Old Business:

1. Two Junior Golfs being sponsored by the men's club have been selected by Dan 'Angelo and hopefully will be able to attend a meet and greet at the Club Championship luncheon August 22nd.
2. Mike Davis reported that if anyone was still having prize fund issues to discuss them directly with the pro shop. Otherwise, there were no other issues to report.

New Business:

1. Revised CVMC Course rules have been updated and posted on the CVMC website. Please encourage all members to take a few minutes to read them. This will certainly reduce confusion and hopefully speed up the pace of play.

New Business Continued:

2. Several changes were made to the CVMC 2021 golf schedule including the Club Championship dates. This way, our Low Gross and Low Net Champions would well represent the CVMC at the year-end NNGA Tournament of Champions in October. The CVMC will fund the entry fees for our players, including a practice round prior to that event.
3. The Tournament Director was tasked with sending out two Golf Genius requests. First, the President and Secretary positions for the 2022 season are open and need to be filled. Any interested individuals need to respond prior to the year-end CVMC Banquet. Second, a request will go asking who plans to attend the year-end CVMC Banquet so an accurate head count can be given to the Country Club restaurant well in advance of the banquet date.
4. Members wishing to compete for the Club Championship "Low Gross" category must play from the blue tees. The "Low Net" participants may compete from the blue, white, or red tees. Please ensure your tee position is noted on your scorecard.
5. A motion was made and approved that the most improved player would have the following year's men's club dues paid by the CVMC.
6. The Public Relations Director was asked to purchase trophies for the Club Championship Gross and Net winners. Also, and to possibly interview and write an article for the local newspaper regarding the CVMC's ongoing sponsorship of the NNGA Junior Golf program, if our two selectees are able to attend the post Club Championship luncheon.
